TERMS & CONDITIONS

1. During the period of rental the instrument remains the property of John N. Bilham Musical Instruments.
2. If the customer does not return the instrument PRIOR to the renewal date, it is assumed they wish to retain the instrument and a further rental fee is charged.
3. The customer understands that only the first 2 rental payments are deducted from the purchase price.
4. Fully comprehensive instrument insurance covering loss, theft or accidental damage to the instrument is free for the first 4 month rental period. After that a compulsory charge of £7.00 per 4 month rental period is payable by the hirer and charged to their credit/debit card. Following the initial 4 month rental period this cover applies to loss or theft only. The hirer also agrees to the £1.75 per month payment protection insurance fee levied if they elect to purchase the instrument over 12 months. No actual instrument cover is provided if you are purchasing over 12 months. At this stage, The Hirer may use our extensive Music Shield Fully Comprehensive Policy to insure the instrument if they wish to do so.

5. The customer is responsible for returning the instrument and any expense incurred for carriage. Please note you are responsible for the instrument until it is returned to us. Please use a recognised carrier such as Interlink or Securicor. (We can help with arrangements if you wish). Please keep all original packaging until you are sure that you want to purchase the instrument. Any free music stand or free saxophone stand supplied is to be returned on return of the instrument. (Excalibur alto saxophone only.).
6. The customer will notify John N. Bilham Musical Instruments of any change in details stated on this Rental Agreement/order form.
7. The customer will advise John N. Bilham Musical Instruments U.K. immediately of any loss or damage to the instrument.
8. The customer takes all reasonable steps to protect the instrument from loss, damage or neglect.
9. Whilst the customer may purchase the instrument under this Agreement, the customer understands that this is a Rental Agreement and not a Hire Purchase Agreement. The customer has the right to return the instrument at any time and at such time will owe no further money.
